The member acknowledges that if it is unwilling or unable to provide financing to the project as otherwise specified in this certification, this will constitute noncompliance with the requirements of AHP, and such noncompliance will be addressed in accordance with the Remedies for Noncompliance section of the AHP Implementation Plan. This may result in the deobligation or recapture of AHP funds.
