Federal Home Loan Bank of New York's Draw Instructions:

To initiate a draw on a Letter of Credit (LOC), a draw certificate bearing wet ink signatures needs to be presented to the FHLBNY in the form of Exhibit A. The draw certificate must be accompanied by the original Letter of Credit, a Corporate Acknowledgement, and must refer to the number on the issued Letter of Credit. Funds under the issued LOC will be made available to the Beneficiary following the presentation to the FHLBNY of the foregoing materials on a day upon which the FHLBNY is open for business (a "Business Day") prior to the Expiration Date of the LOC. Statements contained in the drawing certificate shall be conclusive for all purposes under the issued Letter of Credit.

The FHLBNY will disburse payment no later than the close of business on the next business day following its receipt of the draw certificate. A draw certificate received after 5:00pm (New York City Time) is considered received on the following business day. Any drawing under the issued Letter of Credit will be paid from the funds of the FHLBNY.

Payments under the Letter of Credit will be made by wire transfer of immediately available funds, based on time of presentation, to such account as is designated in the draw certificate.
