## Instruction for reporting loans registered in Mortgage Electronic Registration System ("MERS")

A MERS Electronic Tracking Agreement ("ETA") should be completely executed with the member institution, Federal Home Loan Bank of New York ("FHLBNY"), and MERS.

## **Steps Remaining to Complete this Process**

1. Loans are Registered in MERS:

Loans registered in the Mortgage Electronic Registration Systems ("MERS") are assigned with a MIN Number (18 digit #).

2. Loans are Associated to the FHLBNY:

For loans pledged, loans will need to be associated to the FHLBNY (as Associate Member HLB/FRB) at MERS using our Org ID which is <u>1002493</u>. MERS Helpdesk (at 1-888-680-6377) will need to assist you with this task. You can either enter each loan one at a time or provide a file for a MERS 103 Bulk Update.

3. For Members in Possession Category:

Provide FHLBNY with MERS MIN Summary and MERS Milestones Reports for each loan registered with MERS. Include in mortgage file containing legal documents.

4. Add the MIN# to the Monthly Data Listing:

We will need the assigned MERS Identification Number MIN # populated for each loan at position 1784 for 18 characters in your monthly Mortgage Data Format File Submission to FHLBNY.
